Today, Polski Holding Nieruchomości S.A. Group and the State Fund for Rehabilitation of Disabled Persons signed an agreement on leasing office and warehouse area in the building located at ul. Kolejowa 19 in Warsaw. The agreement was signed for a period of 10 years.

The agreement includes both an extension of the existing long-term rental, and expanding the rental area in the building at ul. Kolejowa 19 in Warsaw. To date, the State Fund for Rehabilitation of Disabled Persons has occupied ca. 2,500 sq.m., whereas under the new agreement it will lease a total of 4,300 sq.m., including ca. 2,000 sq.m. of office area and ca. 2,300 sq.m. of warehouse area. The new and existing rental areas have been redecorated and adjusted to the needs of the disabled.



"We are happy that such an important institution as the State Fund for Rehabilitation of Disabled Persons, which supports the professional and social activity of the disabled, will be located in a building belonging to PHN Group. We are convinced that our existing long-term cooperation will be successfully continued," said Maciej Jankiewicz, President of the Management Board of Polski Holding Nieruchomości S.A.

"Thanks to the agreement with Polski Holding Nieruchomości S.A. Group, we managed to negotiate an attractive rate. It is very important for us, because as a public institution playing a key role in supporting the disabled in Poland, we must ensure that we make good use of public money.
